WHEREAS the Author of the Trust now further feels that certain new clauses have to be amended in the Trust Deed.

# NOW THIS AMENDMENT TO THE TRUST DEED WITNESSETH AS FOLLOWS:

- 1. After clause (25) a new clause, clause (26) under the heading "Winding Up" shall be inserted:
  - "In the event of dissolution or winding up of the trust, the assets of the trust shall be handed over to another trust having similar objects and recognized u/s 12A and 80-G of the Income Tax Act"
- 2. After clause (26) a new clause, clause (27) under the heading "Fund **Utilization**" shall be inserted:

"The funds and properties of the Trust will be solely utilized towards the objects of the Trust."

- 3. Under Object clause, the following clauses are amended:
  - a) Clause-1 stating "To Establish printing press, offset printers, screen printers, manufacturing printing items and supplying private agencies, Central & state government department" to be removed altogether

b) In Clause-2, the words, "Vocational pursuits" to be removed.




